#### **IMPORTANT NOTES**

- It's the responsibility of the parents to deposit the fee as per the scheduled dates.
- Cash will not be accepted against the School fees.
- Parents should mention the name and class of the child on the reverse side of the cheque/DD.
- Please ensure that the cheques are complete in all respects, i.e. date, amount (In figure & words), name and signature of the drawer.
- Bounced Cheque: If in case cheque bounces for any reason, then either cash or DD will be accepted along with the cheque bounce charges of Rs. 500/-
- Late Fee: If the fee is not paid as per the last date given, it will be accepted with a late fee of Rs. 10/per day from the last date of fee submission.
- Fee Reminder: The parents must preserve this fee policy document throughout the year. The school doesn't need to send fee reminders. It's the responsibility of parents to deposit the fee as per the fee schedule.
- Rs. 1000/- will be offered as a concession if the entire tuition fee is paid on or before 30 April 2025 or at the time of new admission.
- 10% sibling discount (In that case, no other discount will be applicable)
- 50% Discount on Admission fees to new parents.
- If you opted for the six installments option, Rs. 600/- will be charged additionally.
- Annual charges include extracurricular activities, school events, field trips, and science experiments
  etc. All students can participate, but Olympiads and other outside competitions, and special event
  outfits are optional and not included
